

Do You Know?



- IT IS NOT MANDATORY YOU ENROLL IN TRSCARE UPON RETIREMENT
- TRS-Care participants have one of two health plans, depending on whether or not they qualify for Medicare ...

Retirees, spouses and dependents without Medica will have coverage through a new TRS-Care Standard pla

Do You Know?



Texas Teacher Retirement System (TRS)

- a public pension plan of the State of Texas
- provides retirement and related benefits for those employed by the public schools, colleges, and universities supported by the State of Texas
- the largest public retirement system in Texas in both membership and assets and the sixth largest public pension fund in the U.S.
- \bullet A Board of Trustees governs the retirement system

Do You Know?



- Eligibility requirements for retiree health benefits are NOT the same as eligibility requirements for the TRS pension plan
- Contact TRS six months prior to your anticipated retirement date to allow yourself enough time to complete/submit all required forms.
- If you plan to work in Texas public education after service or disability retirement, you should carefully review all requirements (Refer to TRS Benefits Handbook)
- In some instances, your social security benefits may be affected by the TRS benefits that you receive. Contact the Social Security Administration (SSA) at 1-800-772-1213 or www.ssa.gov for information on possible offsets or reductions to these benefits ... known as Government Pension Offset and Windfall Elimination Provision (GPO, WEP)

Do You Know?



TRS retirement plan is a defined benefit plan ...

- TRS also administers three other benefit programs established by state law, and are separate from the TRS retirement plan ...
- Your membership begins on your first day of eligible employment with a TRS-covered employer
- As a TRS member, you contribute a percentage of your eligible compensation as your share of the funding for your benefits. The contribution rate is set by the Texas Legislature.

Do You Know?



- The WEP rule only applies to individuals who are eligible for a Social Securibenefit based on their own work history and have a pension from work whe they did not pay Social Security tax. Your social security benefits could be reduced.
- Meanwhile, the GPO rule only applies to individuals who are entitled to a Social Security benefit as a survivor or spouse and have a pension from work in which they did not pay Social Security tax. The social security benefits you receive
- If you have never paid Social Security tax, and only qualify for your teacher's retirement, it's likely you'll never receive a Social Security benefit.
- The Social Security regulations and how differently they may affect a worker's retirement income make it critical that you plan ahead and prepare.

Do You Know?



- Membership in TRS is required by law for eligible employees; participation in the retirement plan cannot be waived.
- Retirement plan membership offers you not only the beginning of your career in Texas public education.
- Death benefits may include an option for your beneficiary to select a benefit that pays a lump sum amount that is equal to twice your annual salary, with the lump sum amount payable capped at \$80,000.
- TRS death benefits are not life insurance payments
- TRS benefits, including death benefits, are not assignable. For example you cannot assign your death benefits to a funeral home to pay for the cost of your funeral.



What Can You Do?



- The state of Texas told its teachers they would receive a pension upon retirement that would provide quality affordable health care coverage during the years following a lifetime of service. Texas has not honored that

- Healthcare costs have skyrocketed. Under 65 retirees have a costly card. Many are paying half their meager earnings on premiums/ded their supplemental policy and spousal costs are excessively expensi
- The Texas Retired Teachers Association is strongly encouraging TRS to pursue additional funds from the Texas Legislature. While state lay prohibits TRS from 10 byly in the Texas Legislature, it is stil TRS to duty to essure that the penion fund is a ctuarially sound so that members may receive cost of living
- To place this financial burden on the retired educators who believed the promise they were given by their employer and who are now struggling financially is unconscionable. Texas has broken the trust that retire teachers had in our system. The state of Texas must address these problems and properly fund Texas ret pensions and healthcare. This is Texas and we keep our promises. We can do this and we must not leave teachers out in the cold.

What Can You Do?



Don't Be Afraid to Ask Your Legislators:

1. Will you support the Defined Benefit Plan?

Rationale: There must be a plan for increasing permanent state funding to ensure defined benefits, retirement security, and a strong pension fund.

2. Will you support Affordable and accessible health care for all Texas education retirees?

Rationale: There is no long-term funding plan to sustain the program. Retirees are willing to pay their share but current premiums are no longer affordable for many of our retirees. The two-year supplemental cycle is not a solution to our health-care funding issue.

 $3. \ \ Will you promote an annuity increase for all retirees?$

Rationale: The cost of living continues to go up, but annuities remain relatively stagnant.

4. Will you support reform at the national level for Social Security offsets (the Windfall Elimination Provision and Government Pension Offset)?

Rationale: Retired Texas teachers are penalized in that the formula for calculating payments for those who qualify for Social Security is arbitrary and treats retired teachers differently from the rest of the population.

General strategies teachers should consider when planning for retirement:

- Consider Professional Help
- Don't Fully Rely on Your Pension Save and Invest through Tax-Advantaged Retirement Accounts (you should be eligible to contribute to a 403(b) plan)
- Don't Count on Social Security
- Will You Work After You Retire from Teaching?
